Notices to Exhibitors:

Due to an overload of obedience entries in Obedience Trials #1 & 3, the following replacement judges have been made and approved by the CKC.

Judge Diana MacKenzie will replace Judge Leslie Marshall to judge the Pre Novice, Novice A & Novice B Classes in Obedience Trial #1 Saturday September 20/2025 @ this Event.

Judge Lisbeth Booth will replace Judge **Diana MacKenzie** to judge the Pre Novice, Novice A & Novice B Classes in Obedience Trial #3 Sunday September 21/2025 @ this Event.

The following Rules from the 2025 Obedience Rules & Regulations will apply:

3.4.2 Replacement Judge

(a) Where a trial-giving club is notified before or after the issuance of a judging schedule, but prior to the day of the trial, that an advertised judge will not, for whatever reason, be able to fulfill a judging assignment, attempts will be made to secure CKC approval for a replacement judge. If CKC approval cannot be obtained, the club will then seek the approval of the local CKC Director or Obedience Representative. The club will subsequently notify the CKC of the circumstances of the approval and of the changes made.

(b) All those who have entered dogs under the advertised judge shall be allowed to withdraw at any time prior to judging that trial. All requests for withdrawal shall be in writing and all entry fees and listing fees will be returned to the owner or the authorized agent of the dog. When possible, the trial-giving club will attempt to notify exhibitors of the judging change at the time the judging schedule is sent out.

In all cases, changes in judges will be posted in a prominent location at ringside.

3.4.4

A qualifying score earned under a substitute or replacement judge will be considered as having been earned under the advertised judge.

General Exhibitor Information:

Day of Entries will not be considered for Obedience Trials 1,2,3,4 or Rally Obedience Trials 3,4 due to Judge Overload. Limited space for Day of Entries will be available for Rally Trials 1,2,5,6 however please email acddogsports@gmail.com to confirm the possibility as we do not want to inconvenience you by travelling to the venue.

Exhibitors can bring their own folding chairs and crates into the venue, however, please have something to put under your kennels & chairs in the venue i.e.: RV mats or blankets, the entire venue is matted, and we do not want to mark or penetrate their matting with any sharp edges from crates or chairs.

Please bring **indoor shoes** for the venue and change your footwear in your benching area.

Exercising Dogs – There is plenty of space on the Southend of the property on the other side of road, the driveway is a dead end and there is undeveloped area to exercise dogs. Please confirm the designated Dog Exercise area with a club member if you are unsure.

Please do not park directly in front of the doors to any of the businesses or sidewalk in the complex. There is plenty of space to form two rows of parking spaces in the parking lot that are not adjacent to sidewalks or doors.

Please adhere to all rules stated in the CKC 2025 Obedience & Rally Rules & Regulations and the following Venue rules put forth by the Venue Owners.

Integrity Dog Sports Facility Rules for All Events

Treatment of animals and humans:

Our facility promotes the kind and fair treatment of animals and humans alike. The following behaviour will NOT be tolerated at any event.

Harsh or over-the-top verbal scolding of dogs for the purpose of punishment, physical corrections of any kind, use of aversive devices on-site including e-collars or vibration collars, prong or pinch collars.

Any event attendees doing so will be dismissed immediately without a refund.

Exhibitors' responsibilities. Dogs are to always be ON-LEASH and UNDER CONTROL, unless in the designated working or warmup areas. Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without the benefit of a refund if the event organizer deems the exhibitor to be in violation of this requirement.

The trial committee of any trial may decline any entry or remove any dog from its trial for just cause and no one shall have any claim or recourse against the organization holding the trial or any official connected therewith. Said officials must file their reasons for doing so with the CKC not less than 14 days after the trial has been held.
